a. Secretary/Registrar-Change of wording on previous minutes to reflect Representative(s)/ Liaison(s).

b. Lit. Rep.

Reports cost of a case of Big Books -\$171.00 and 12&12 \$155.00. We voted to lower the total literature expenses from last years (\$600) to \$400 for this year. After the purchase of (1) case of Soft Big Books and (1) case of Soft 12&12's we will have a budget of \$74 left for literature for the year. These books will cover current needs for Day-mark Lexington IOP & Lexington Detox with (6) soft 12&12's left and (12) soft Big Books for future needs. Davidson correction has a stated need of (6) more 12&12's will need a revote as we donated to them last year.

- c. Webmaster- Notes meeting with web developer about new site. Developer encourages a competition for a "logo" to be created by a community member in digital form.
- d. Treasurer- Reported 2017 opening balance was \$1693.22 from checking account. There was one disbursement of \$11.71 for checks. Committed debits are listed as follows: Rent- \$180.00- for (1) year at club, DCM/Alt. DCM- \$448- for the year. [(2) Assemblies and (2) Committee meetings a year.], P.O. Box fee- \$70 a year, CTC- Conference trip- \$110, Website reconstruction- \$200 Approx. Committed Total- \$1020.71
- e. CPC/PI- not present- T.C. reported, Family Services of the Piedmont (High Point) about bringing AA (literature/meeting) to their facilities. Area 51 TFC has contacted us about Nazareth Child & Family Connection to assist them with their Lexington Location. Their request will include literature and possibly a person from the program to introduction the program to the staff & clients. Possible meeting day and time could be on Tuesday 11 AM or every other week. (Every 3 weeks, to start, if necessary.)
- f. CFC-not present-T.C. reported
 - Davidson Correctional- Could use (6) more soft 12 & 12's (District donated books last year to this facility.)
 - 2. High Point Jail needs have been met with (2) totes at a cost of \$34.32 (8) pocket sized Big Books and (2) regular sized soft Big Books, which district already had in stock.
- g. TC-Reports Facilities with needs:

Day-mark (IOP)-Lexington requested (6) 12 & 12's for IOP program and is also opening a Detox facility in April. This facility was promised (10) soft 12&12's and (10) soft Big books last Fall. (The coordinator there said they could surpass with (8) of each.)
